Opportunities for learning include competency-based clinical practice with qualified VHA preceptors and didactic or classroom experiences as deemed appropriate.

Expectations and Goals

- VALOR Students are expected to complete their committed 400-hours prior to October 1, 2019; and an additional 400-hours prior to graduation (Est. 50-hours per month Oct 2019 to April 2020).
- VALOR Students are expected to strongly consider the VA for employment post-graduation; Post-Bachelorette & Transition-to-Practice Residency Program application information will be provided and special consideration for hire will be afforded VALOR Students showing dedication & competency in practice.
- VALOR Students are expected to demonstrate above average organizational, critical thinking, and technical skills; evidence strong interpersonal effectiveness, personal mastery, and environmental awareness; and conduct themselves professionally throughout the program inside and outside the VA.
- VALOR Students must to provide the VALOR Coordinator a Competency Validation list from UFCON identifying skills already been validated by Instructors.
- Through competency-based clinical practice and varied educational programs the VALOR student will:
 - Obtain an overall view of the Nursing Profession and the various roles of the Professional Nurse.
 - Gain clinical experience within select clinical and specialty areas throughout Nursing Service.
 - Become familiar with policies, procedures, and programs specific to the VA system.
 - Gain a unique perspective on providing care to our nation's various Veteran populations.
